The Hyde Amendment

The facts

The Hyde Amendment bars the use of federal funds for abortion with exceptions for rape, incest, or life endangerment. This restriction applies to Medicaid recipients, government workers, and Peace Corps volunteers.

We know that **one in three women will have an abortion in her lifetime**. A woman who pays for an abortion out of pocket may be forced to delay the procedure to raise the necessary funds. Fifty-eight percent of abortion patients say they would have preferred to have their abortion earlier.

Abortion restrictions like Hyde and others **force an estimated 1 in 4 poor women to continue an unwanted pregnancy.** Younger people, in particular, are more likely to carry an unwanted pregnancy to term.

Why it matters

With Hyde in place, people who are seeking an abortion are forced to divert money intended for other things, such as paying bills or buying food for their families, or in some cases selling their belongings. These restrictions only force more low income people to sacrifice their financial resources to seek out a safe and legal medical procedure.

Young people are more likely to work low-income jobs that do not provide health insurance. Low-income people are likely to rely on Medicaid for their health care needs and as such face a huge burden in seeking and paying for abortion care.

Everyone should have access to a full range of pregnancy related care, including abortion, regardless of where they live or how much money they make. Political beliefs should not trump a person's ability to access quality healthcare.

When a pregnant person decides to end a pregnancy, it is important that they have access to safe medical care. Providing insurance coverage ensures that someone seeking abortion care will able to see a licensed, quality health care provider.
